End of Phase 1 Training Notes

On being taken, the boy was intended to be used for behavioural modification of his sister [REDACTED] and was deemed disposable. However, during his initial interview, it was deemed that the boy showed high levels of intelligence and may be suitable for training as a Predator despite his tender age.

Initially, it was ruled that he was too young and he was to be prepared for sanction, however, it was pointed out the template for the program, Hit Girl, was only five when her training was begun. For security reasons, the boy was immediately moved to the facility at [REDACTED] to separate him from his sibling during training.

During the latter part of Phase 1, a scheduling error allowed the two siblings to both be present at the [REDACTED] facility in England.

Despite a slow start and a period of two months before his training commenced, James has progressed well. He is the youngest in his class, by a long way. This has laid him open to bullying from the other male trainee Predators to which he has responded in kind. The female trainee Predators have generally ignored him.

One Phase 2 boy has proved to be a major problem, but so far, James has reacted well.

The initial indoctrination phase was accomplished without any issues and James is deemed suitable both academically and qualification wise to proceed to his Phase 2 training. His academic scores have been good and very surprising for his tender age. He has excelled at Weapons Training and has a good eye on the range. He appears to favour violent weapons and has taken to bladed weapons and explosives with a disturbing keenness.

His more physical training has been severely limited by his stature. As his body grows, he should prove to be an exceptional Predator.
