End of Phase 1 Training Notes

March, 2014: Killed ...

Stephanie had a very slow start and initially, she was expected to be terminated within weeks due to her inability to integrate into the training. However, at the proverbial eleventh hour, she showed great prowess in CQC against another trainee Predator who it appeared pushed the girl too far (see Incident Report in Restricted Appendix). As a reward for her behaviour and display of exceptional skill, Stephanie Walker was awarded her codename in recognition of her actions.

Since that moment, Stephanie Walker has shown an aptitude to fighting and has shown outward aggression towards her fellow Predators, specifically another Predator, Saoirse Doherty. Stephanie has shown a raw aptitude for being trained as a Predator and is expected to excel. Indeed, a confidential nemesis has been allocated as a counter to her advanced progress.

The initial indoctrination phase was accomplished without any issues and Stephanie is deemed suitable both academically and qualification wise to proceed to her Phase 2 training. Her academic scores have been exceptional and very surprising for her age range. She has excelled at Weapons Training and has a good eye on the range. She favours violent weapons and has taken to bladed weapons and explosives with a disturbing keenness.

Her more physical training has only been limited by her stature, but she has shown that she can take on other Predators twice her size and win. Indeed, most Predators are wary at fighting her as they know that she has already killed and has not shown any remorse for having done so. As her body grows, she will prove to be an exceptional Predator.
